

Terms and conditions

1. Eligibility and Entry restrictions

- a. The offer is valid on only Comprehensive Car Insurance and not Third Party Car Insurance
- b. The offer is valid for GCC Specifications cars only
- c. Participants must be at least 18 years old and based out of United Arab Emirates
- d. Participants must not be an agent, or an employee, of Policybazaar.ae
- e. The maximum number of entries to a competition per person is one
- f. Policybazaar.ae is currently offering a discount of up to 30% on comprehensive car insurance premiums.
